**Consultation and participation:** To consult and involve workers and their representatives in all areas, including those related to the Health and Safety Committee.



**Food safety:** To guarantee the highest level of quality and food safety in the supply chain, establishing a self-monitoring system by means of HACCP applied to the entire procedure, controlling from suppliers to service.
